



RULES AND REGULATIONS FOR THE 2009 FETISH FAIR BOOTBLACK CONTEST

- Canadian Citizen or Landed Immigrant
- 21 Years of age and over
- Living in the Greater Toronto Area
- Contest open to all genders
- All Contestants will compete in the 2009 Fetish Fair Bootblack Contest, Sunday, August 17, 2008, during The Church Street Fetish Fair, and are required to sign that attached 2009 Fetish Fair Bootblack Contestant Agreement and Photo release. Contestants agree to appear on stage at the scheduled events including, but not limited to the Church Street Fetish Fair Bootblack Competition, and for the Panel interview section of the competition. The contest times are between, but not limited to, 12:00pm and 6pm, on the date of the Contest. If for some reason a Contestant misses or is not able to attend one of the above functions he or she will be automatically disqualified from the Contest.
- The 2009 Fetish Fair Contest is open to persons of all genders, 21 years of age and older, who are Canadian citizens or landed Immigrants, who live in the Greater Toronto Area (ie; within a two hour commute of Toronto) Contestants maybe required to show identification, or proof of citizenship.
- 2009 Fetish Fair Contestants application forms must be received by The Church Wellesley Business Improvement Area office by the due deadline, no later than Tuesday, August 05, 2008 at 5:00pm. Following the receipt of an application to the Contest Coordinators they will contact the Contestant to confirm his or her status, and to advise the Contestant when and where to report.
- Fetish Fair Contestants will be judged by a panel of three judges chosen for their knowledge and interest in the art of bootblacking. Each Judge will receive one Boot Shine from each Contestant. Contestants will be judged in four categories: Panel Interview, Technique, Artistry, and Customer Relations. The Fetish Fair Bootblack Contestant who receives the highest total of judge's score will be named "Fetish Fair Bootblack 2009".
- In the event that there is only one Contestant running for the Fetish Fair Bootblack Contest, the Contestant must receive a final score of 70% or better of the total possible points. The total possible score is 300 points. (3 Judges x 100 points per judge) Therefore, the single Contestant must receive a final score of 220 to be awarded the title.
- Or In the event that there is only one Contestant running for the Fetish Fair Bootblack Contest, The Church Wellesley Business Improvement Area (BIA), or the organizers of the Church Street Fetish Fair reserve the right to appoint a person to the Title.
- Any gratuities received by the Contestant will be his or hers to keep or to donate to the charity of their choice at the Contestant's sole discretion.
- The winner of the contest will have the option to go on to the Mr. Leatherman Toronto Bootblack Competition in November.
- All Fetish Fair Bootblack Contestants agree to adhere to all the rules of the Competition, and to the rules of The Church Street Fetish Fair. The BIA and Church Street Fetish Fair also reserve the right to remove any Contestant from the Contest for any reason.
- Fetish Fair Bootblack Contestants are required to provide all information requested on the application form, and sign the accompanying 2009 Fetish Fair Bootblack Contestant Agreement and Photo Release.
